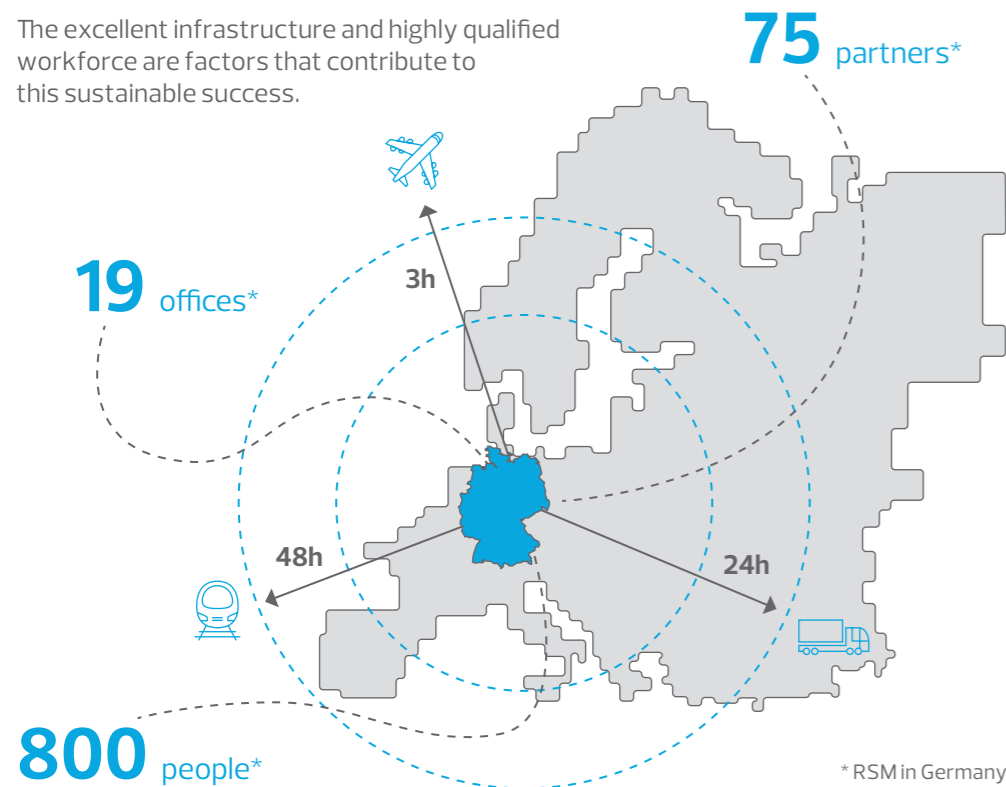


## GERMANY OFFERS OUTSTANDING MARKET OPPORTUNITIES

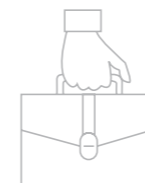
